I also understand that the installation of irrigation equipment and landscape materials may not result in a lower water bill. I agree to defend, indemnify and hold harmless the WRASBC and its member agencies, their directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorneys' fees, arising out of or resulting from participation in the Program, including without limitation the installation of irrigation equipment and landscape materials. I also agree to allow the WRASBC to review water consumption records at the property where the turf conversion took place to quantify water savings from the program.
